Executive Summary

In the year ended the ninth month as of 30 September 2022, the Company had total revenue of Baht 458.80 million, a decrease of 3.92% YOY. The total cost of sales and services amounts to Baht 232.57 million, an increase of 0.69% YOY. Resulting in a higher gross profit amount of Baht 63.73 million, a growth of 13.89% YOY. Distribution costs and administrative expenses amounted to Baht 66.58 million, a decrease of 6.21% YOY. Net loss for the ninth month period amount of Baht 5.06 million, (1.10%) decreased from the same period with the previous year amount of Baht 19.04 million, 135.19% YOY, and EBITDA in the third quarter of 2022 amount of Baht 6.54 million.

The Company's major reasons for the performance for the third quarter of 2022, the Net loss was impacted by the salesprice competition, including mainly impact from raw material costs such as steel price raise the price also rising oil prices, hence cost of production and cost of goods sold were raise also labor cost.

Total revenues

The period the ninth month ended on September 30, 2022, the Company had a total revenue amount of Baht 458.80 million, 3.92%, consisting of revenue from sales amount of Baht 282.08 million, which decreased 5.28%, consideration with Q'3/2022 revenue from the sale, it's decreased from the previous year, but revenue from construction amount of Baht 171.44 million, decreased 3.03%, revenue from service amount of Baht 1.61 million, increased 1.26% and other revenue amounts of Baht 3.67 million, 175.94%

The period of three months ended on September 30, 2022, the Company had a total revenue amount of Baht 154.14 million, which increased to 24.56% from the prior period, and revenue from sales increased to Baht 112.37 million (41.52%), revenue from construction is the amount of Baht of 39.76 million, it is decreased 6.34%, revenue from service is the amount of Baht 0.44 million, it is decreased 10.20%, and another revenue is the amount of Baht 1.57 million, it is increased 11.35%

Cost of sales and services

The period the ninth month ended on September 30, 2022, the Company had the total Cost of sales and services amount of Baht 395.07 million, 86.11%, an increasing amount of Baht 7.10 million, an increase of 1.83% YoY, Cost of sales and services had increased by the amount of Baht 232.57 million, increased of 82.45% YoY, there is Cost of construction increased by the amount of Baht 162.50 million, 94.48% YoY of total revenue. Mainly increase was impacted by the higher competition and the raise in the cost of the main raw material (steel).

In the period of three months from July 1, 2022, to September 30, 2022, the Company had the total Cost of sales and services amount of Baht 128.46 million, 83.33%, a decreasing amount of Baht 20.49 million, 18.89% QoQ, Cost of sales and services had decreased by the amount of Baht 90.17 million, 80.24% QoQ, there is the Cost of Construction amount of Baht 38.29 million, 96.30%. Mainly decreased were impacted by sales volume was lower than the last quarter, because of the guideline company competition also with mostly the Revenue of Construction was recognized.

Distribution costs and administrative expenses

The period the ninth month ended on September 30, 2022, the Company had total distribution costs and administrative expenses amounting to Baht 66.58 million, with 14.51%YoY of total revenue, decreased by an amount of Baht 4.41 million, 6.21%YoY. Distribution costs were decreased, and there were mainly impacted by Oil and Gas transportation expenses but administration expenses decreased, mainly decreasing from employee bonus payments, salary payments also with professional fees, and bank fees.

The period the three months from July 1, 2022, to September 30, 2022, the Company had total distribution costs and administrative expenses amount of Baht 21.94 million, with 18.24% QoQ of the total revenue, there is rising in the amount of Baht 0.63 million, with 2.79% QoQ. As a result of Oil and Gas transportation expenses, administration expenses decreased, mainly from employee bonus payments, salary payments, professional fees, and bank fees.

Gross Profit and Net Profit

The period the ninth month ended on September 30, 2022, the Company's gross profit amounted to Baht 63.73 million, the Loss after corporate income tax for the period amounted to Baht 5.06 million, Earning per share was the number baht (0.011) EBITDA was the amount of Baht 6.54 million. Unappropriated retained earnings amount to Baht 43.95 million.

From a decrease in current asset amount of Baht 47.03 million by Construction contract-unbilled decreased amount of Baht 13.26 million, Cash and cash equivalents amount of Baht 9.12 million, Inventories decreased amount of Baht 4.74 million and increase of Trade-account receivable amount of Baht 52.51 million, Short-term loan increased amount of Baht 32.50 million, Non-current assets decreased amount of Baht 4.14 million, and increased amount of Baht 2.48 million, impact from Plant, property, and equipment also increased from non-current contract assets and deferred tax assets too.
