Executive Summary

In the year ended the ninth month as of 30 September 2023, the Company had total revenue of Baht 446.57 million, a decrease of 2.33% YOY. The total cost of sales and services amounts to Baht 349.02 million, an decrease of 11.66% YOY. Resulting in a higher gross profit amount of Baht 97.55 million, a growth of 21.95% YOY. Distribution costs and administrative expenses amounted to Baht 70.65 million, increase of 6.61% YOY. Net profit for the ninth month period amount of Baht 19.98 million, (4.50%) increased from the same period with the previous year amount of Baht 25.04 million, 494.86% YOY, total comprehensive income amount of Baht 21.05 million and EBITDA in the third quarter of 2023 amount of Baht 36.99 million.

The Company's major reasons for the performance for the third quarter of 2023 was become net profit because of the lower of steel price when it was compared with prior year, gross margin from service constructions segment was increased as a result of new project launched and there are continuedly operation.

Total revenues

The period the ninth month ended on September 30, 2023, the Company had a total revenue amount of Baht 446.57 million, 2.33%, consisting of revenue from sales amount of Baht 298.27 million, which increased 5.74%, consideration with Q'3/2023 revenue from the sale, it's increased from the previous year, meanwhile the revenue from construction amount of Baht 144.64 million, decreased 15.63%, revenue from service amount of Baht 1.44 million, decreased 10.56% and other revenue amounts of Baht 2.21 million, increased 4.74%

The period of three months ended on September 30, 2023, the Company had a total revenue amount of Baht 177.22 million, which increased to 32.64% from the prior period, and revenue from sales increased to Baht 104.09 million (7.81%), revenue from construction is the amount of Baht of 72.45 million, it is increased 100.86%, revenue from service is the amount of Baht 0.47 million, it is decreased 9.62%, and other revenue is the amount of Baht 0.21 million, it is decreased 55.32%

Cost of sales and services

The period the ninth month ended on September 30, 2023, the Company had the total Cost of sales and services amount of Baht 394.02 million, 78.54%, an decreasing amount of Baht 46.05 million, a decrease of 11.66% YoY, Cost of sales and services had decreased by the amount of Baht 215.35 million, increased of 72.20% YoY, there is Cost of construction decreased by the amount of Baht 133.67 million, 92.42% YoY of total revenue. Mainly decrease was impacted by the less in the cost of the main raw material (steel) price and the revenues of construction.

In the period of three months from July 1, 2023, to September 30, 2023, the Company had the total Cost of sales and services amount of Baht 138.04 million, 77.98%, a increasing amount of Baht 30.33 million, 28.97% QoQ, Cost of sales and services had decreased by the amount of Baht 71.49 million, 68.68% QoQ, there was the Cost of Construction amount of Baht 66.55 million, 91.86%. Mainly decreased were impacted by selling price this quarter was higher than the last quarter, because of new project launched.

Distribution costs and administrative expenses

The period the ninth month ended on September 30, 2023, the Company had total distribution costs and administrative expenses amounting to Baht 70.65 million, with 15.82% of revenue (YoY), there were increased (amount of Baht 4.07 million ,6.11%) because of administrative expense was increased affect from head office salary, bonus, vehicle depreciation, miscellaneous expenses also with loss from asset disposal. Distribution costs were increased, and there were mainly impacted by bonus expenses, repair and maintenance but oil and gas transportation expenses, depreciation of vehicle, tools and equipment were decreased.

The period the three months from July 1, 2023, to September 30, 2023, the Company had total distribution costs and administrative expenses amount of Baht 24.91 million, with 14.07% QoQ of the total revenue, there is rising in the amount of Baht 3.28 million, with 15.64% QoQ. As a result of reimburse expenses, oil and gas transportation expenses, maintenance expenses, agency and miscellaneous expenses, a decreasing of administration expenses, bank fees and miscellaneous expenses.

Gross Profit and Net Profit

The period the ninth month ended on September 30, 2023, the Company's gross profit amounted to Baht 97.55 million, net profit after corporate income tax for the period amounted to Baht 19.98 million, Total comprehensive income amounted to Baht 21.05 million, Earning per share was the number baht 0.0434 EBITDA was the amount of Baht 36.99 million. Unappropriated retained earnings amount to Baht 79.51 million.
