Overview

The performance of twelve months of the year ended 31 December 2023, the company's revenue is 684.40 million Baht, which increases 9.67% from the same period of the previous year. The cost of sales and service is 531.63 million Baht, which increases 1.21%. Therefore, the gross profit increases to 152.77 million Baht, accounting for 22.32%. Sales and administrative expenses is 97.34 million baht, which increases by 5.43% from the same period of the previous year. Net profit of the twelve months is 42.86 million Baht, accounting for 6.26% which increases from the previous year by 353.54%. EBITDA for the twelve months of 2023 is 68.34 million Baht.

The major reason for the increasing net profit of the performance of 2023 is the increasing gross profit from the product sales since the cost of raw materials: steel and PC wire, which decreases from the previous year, and the gross profit from the construction increases from the new project that meets the schedule.

Total revenue

For the twelve months of the year ended 31 December 2023, the total revenue of the company is 684.40 million Baht, which is from the sales revenue of 432.82 million Baht, which increases 15.08 million Baht, or 3.61% from the same period of the previous year and increases from Q3 by 30.46 million Baht, or 29.26%. The increasing sales revenue is from the increasing concrete product sales. The construction revenue is 246.51 million Baht, increases from the same period of the previous year by 45.35 million Baht, or 22.54%, and increases from Q3 by 29.42 million Baht, or 40.61%. The increasing construction revenue from the same period of the previous year is from the revenue recognition from the new project, and the service income of 1.80 million Baht, which decreases by 12.62%, and other revenue of 3.27 million Baht, which increases 4.81%. Most are the revenue from the cancellation of retention refund of the contractor due to the fault in work improvement.

Cost of sales and services

The cost of sales and services for the twelve months ended 31 December 2023 is 304.60 million Baht, accounting for 70.38% of the income, which decreases from the same period of the previous year by 32.79 million Baht, or 9.72%. The cost of sales decreases because of the increasing sales of concrete products and the decreasing cost of raw materials: cement, steel, and PC wire.

The cost of construction for the twelve months ended 31 December 2023 is 227.03 million Baht, accounting for 92.10% of the income, which increases by 39.13 million Baht from the same period of the previous year, or 20.82%, and from Q3 by 26.81 million Baht, or 40.29%. The increase is from the cost of construction work from the new starting work as planned.

Sales and administrative expenses

The sales and administrative expenses for the twelve months ended 31 December 2023 is 97.34 million Baht, which increases from the same period of the previous year by 5.01 million Baht or 5.43% due to the increase of bonus of salespersons and transport staff, allowance of transport staff, vehicle repair and maintenance, and commission to the outsiders, and the decrease of depreciation of machine and equipment and vehicle of transportation department.

The increase in administrative expenses is from the bonus of management, depreciation of vehicle of management, bank fee, and the decrease of loss from asset gain and notice of delay penalty.

Gross profit and net profit

For the gross profit and net profit of the twelve months ended 31 December 2023, the gross profit is 152.77 million Baht, which increases 53.98 million Baht, or 54.64%, from the same period of the previous year, and 15.94 million Baht, or 40.63% from Q3. The net profit after deducting the corporate income tax for the twelve months of 2023 is 42.86 million Baht, which increases 33.41 million Baht, or 353.54% from the same period of the previous year, and 12.61 million Baht, or 122.78% from Q3. The major reasons are the decreasing cost of concrete product sales, the percentage of the cost of construction, and the increasing sales and administration expenses. The loss from the investment using the equity method has a profit 0.0932 Baht per share, and EBITDA is 68.34 million Baht.

Financial statement

Asset

As of 31 December 2023, the total asset is 657.47 million Baht, which increases by 124.00 million Baht from 2022. It is the increase from the current asset by 105.82 million Baht. Most are the increase of cash and cash equivalent, 15.94 million Baht, accounts receivable and other receivables, 63.64 million Baht, and inventory, 33.03 million Baht, and the decrease of short-term loan, 12.50 million Baht.

The increase of non-current assets is 18.18 million Baht. Most are from the increase of investment of the associated company, 52.97 million Baht, and the decrease of assets from the non-current contract, 27.38 million Baht, land and equipment, 3.33 million Baht, using right assets, and deferred tax assets.

Liabilities and shareholder's equity

As of 31 December 2023, the total liability is 261.17 million Baht, which increases by 80.03 million Baht from 2022. The increase is from the current liability of 80.19 million Baht, the short-term loan from the financial institute of 37.31 million Baht, the account payable and other current payable of 30.14 million Baht, the liability from the current contract of 13.78 million Baht, the decrease of the current portion of liability from the lease contract and the accrued corporate income tax of 0.52 million Baht, and the decrease of Non-current liability of 0.16 million Baht. Most are the decrease of the estimated non-current liabilities for the employee's benefit and the increase of liability from the lease contract.

As of 31 December 2023, the shareholder's equity is 396.30 million Baht which increases 43.97 million Baht from 2022. It is the increase in operating profit in 2023. This year, the company has set the legal reserve for 5% of the net profit, which is 1.4 million Baht. Therefore, the legal reserve of the company is 22.58 million Baht. accounting for 9.82% of the registered capital.

Cash flow statement

As of 31 December 2023, the company's cash flow is 133.55 million Baht, which is from the cash and cash equivalent at the beginning of the period as of 1 January 2023, 117.61 million Baht, plus 29.58 million baht of net cash from the operating activities. Most are the increase from the accounts receivable and other current receivables, inventory, accounts payable and other current payables, liability from the contract, and the decrease of tax expenses, loss share from the investment in the associate company deducting the net cash spending in the investment 49.23 million Baht. Most are the cash to buy the investment fund in the associate company, cash for the short-term loan to other businesses, and cash received from short-term loans from other businesses, plus the net amount from the fundraising activity of 35.59 million Baht, which is the cash from the short-term loan from the financial institute and cash to pay for the short-term loan from the financial institute.
